Simply sign in online to your HSBCnet account to select tax payment types, make or cancel a payment (including future-dated payments) and view your transaction history.

Secure

- ◆ Secure online environment for making tax payments



Available 24/7

- ◆ Submit tax payments any time
- ◆ Customer support is available Monday to Friday, from 8:00 am to 8:00 pm EST



Next-day payment

- ◆ Payments can be made up to 11:59 pm EST the business day before the transaction is due



Control

- ◆ Online confirmation number provides an easy reference to track transactions
- ◆ View transaction payment history
- ◆ Assign multiple authorizers – more than one person can be authorized to submit transactions



Convenient

- ◆ Future-date payments up to one year in advance
- ◆ View and cancel a future-dated transaction
- ◆ Cancel a payment up to 11:59 pm EST, the business day before the transaction due date
- ◆ No postal delays or visits to a bank branch

Step 3

From the main page, you can:

- ◆ add, edit or remove payment types
- ◆ make a payment
- ◆ view or cancel future-dated transactions
- ◆ view your transaction history
